**Subject: Amendment to the Last date for submission of TRQ Application for various FTA's notified under Appendix-2A of the FTP, 2023 for FY-2026-27 -reg.**

Reference is drawn to Appendix-2A of the FTP, 2023, wherein all the Free Trade Agreements (FTAs) / Preferential Trade Agreements (PTAs) are notified.

2. In reference to the above, in exercise of the powers conferred under Paragraphs 1.03 and 2.04 of the Foreign Trade Policy, 2023, the Directorate General of Foreign Trade hereby extends the last date for submission of TRQ applications for the FY 2026-27 under the following products under the respective FTAs from **28.02.2026 to 15.03.2026**:
